The Contour chair passed the BS EN 16139: 2013 Test Level 1 General contract use.

The Contour chair is registered with ACID (Anti Copying In Design).

Workstories Ltd offers a 5-year warranty on our Atelier range.

This applies only if products have been used within and by standard office conditions. Wear and tear must be expected from normal use and are not covered by the warranty. Manufacturer's warranty applies to all fabrics.

CLEANING & CARE

The furniture should be regularly cleaned with a soft, dry cloth. If required, a damp, soft cloth may be used. Do not use abrasive, ammonia, bleach, spirit or oil-based cleaners, including D10 sanitiser. Periodically check and tighten hardware as necessary.

UPHOLSTERY

Upholstered furniture gets dusty and this can dull the colours and reduce the life of fabrics. Lightly vacuum or brush regularly but never use a stiff brush as this could damage the fibres. If you spill something on the upholstery, wipe excess liquid up immediately with a clean absorbent cloth. Then follow the fabric

manufacturers cleaning instructions.

Environmental Practices

During the design process we ensured that any aspects of the design which could be produced using recyclable or recycled materials, was done so. Using die-cast aluminium for the 4-star, 4-star with castors, 5 star with castors and 4 star lounge base, aluminium is infinitely and widely recyclable. Mild steel forms the sled and 4 leg base, steel as an average contains 25% previously recycled steel and is recyclable at the end of its life.

Where plastic components were required for use (such as foot glides), we liaised directly with the supply chain to ensure that the plastic components were easy to disassemble and could be recycled by the end user. Ensuring that Contour is modular is another key to its sustainable credentials, bases can be interchanged at any time and are not moulded into the chair.

The upholstery was also designed to be easy to remove and re-upholster, achieved using a zipped jacket, whilst a removable seatpad and headrest ensure these high-wear areas can be re-upholstered individually without the requirement to disassemble and re-upholster the whole chair. This consideration for the upholstery cover will allow the internal frame and foam of the chair to be continuously used and recovered throughout the product lifespan. Where we have not been able to use recycled or recyclable materials, we have ensured that the specification of the material used is hardwearing and built to last.


